AGREEMENT FOR BEACH CLEANING SERVICES

The Village of Charlo is seeking to enter into an agreement with an individual to perform beach cleaning services at the Charlo Beach. The agreement with the terms may be obtained from the village office, 614 Chaleur Street, Charlo, New Brunswick, Monday through Friday from 9:00 a.m. to 4:00 p.m. or on the village web page: www.villagecharlo.com This agreement will be received up to Friday June 1st, 2018 at 2:00 p.m. at the village office, 614 Chaleur Street, Charlo, NB

There is approximately more or less 1 km of beach to be cleaned. This individual will be required to perform beach cleaning services for the Village of Charlo.

Duration: 8 weeks (starting Sunday June 17, 2018 up to an including Saturday August 11, 2018)
Between 20 to 25 hours per week should be needed to perform this work.

The individual would utilize his own equipment (Ex: chainsaw, four wheeler, rake, fuel, etc.....). The individual will not be provided with an overnight storage area by the Village of Charlo for any equipment or trash bins. The individual will be responsible for overnight equipment storage and all associated costs. All equipment utilized by the individual shall be in good operating condition at all times.

The successful individual shall maintain, at his expense, Auto and Comprehensive General Liability Insurance. The successful individual further agrees that he shall protect himself and save harmless the Village of Charlo, from any and all claims, demands, losses, costs, damage, actions, suites or proceedings. The individual will be responsible for any expenses, complaints and damages incurred as a result of performing the duties of this agreement. Repairs will have to be done by the individual, at the individual's expenses, within a reasonable time or the individual will be billed by the Village of Charlo for work performed.

If in the opinion of the Village of Charlo, the terms of the agreement are not satisfactorily met, the Village of Charlo reserves the right to cancel the agreement immediately. Upon such decision, a written notice will be issued to the individual advising him of the termination of the agreement and payment will cease immediately. The individual will not have the right to claim any compensation of any kind as a result of the agreement being cancelled. Cancellation of the agreement shall not relieve the individual of his liability for work performed under the agreement prior to the cancellation date.

The individual agrees not to assign or transfer this agreement or any part hereof without first having obtained the consent from the Village administrator in writing.
